**100. DoD and Service IGs: How many claims of sexual assault retaliation have been reported through the DoD or Service IG hotlines in FY12, 13, and 14?**

| <b>DoD</b>  | <p>(DoD IG) I (Nilgun Tolek) testified in April of this year before the JPP that the following number of sexual assault-related reprisal complaints were filed in those years. | <b>USAF</b> | <p>(SAF/IG) The Air Force IG receives complaints through a variety of methods: in person, by mail, electronic mail, and telephonically (hotline). The total number of sexual assault related cases of reprisal during FY12, FY13 and FY 14 breaks out as follows: FY12=0, FY13=2, FY14= 4. CGIS may also receive complaints for retaliation. While CGIS recently acquired an electronic, online case database, Field Activity Tracking System (FACTS), IG cases are compiled together, and not by specific categories of IG complaints.
