Attached is the SVC Program Week 86 Wrap-Up:

Total SVC Requests/Assignments:

- Eligible Victim Requests Received Over Life of Program – 1096
- Current Case Load SVCs are Carrying - 622
- Atty-Client Relationships Terminated - 473
- Attended Courts-martial - 166
- Attended Article 32s – 200
- Attended Interviews - 1656

FY 14 SVC Requests/Assignments:

- Eligible Victim Requests FY 14 – 610
- Attended Courts-martial - 83
- Attended Article 32s – 115

No Change to Victim Impact Survey (VIS):

- 90% "extremely satisfied" with the advice and support the SVC provided during the Article 32 hearing and court-martial (9% "satisfied"; 1% "dissatisfied");
- 99% would recommend other victims request an SVC;
- 95% indicated their SVC advocated effectively on their behalf;
- 96% indicated their SVC helped them understand the investigation and court-martial processes

Victim Feedback from VIS:

“The legal process is very confusing for small matters, but for such a large and personal matter in which many aspects of your life are thrown upside down as the victim of a sexual assault having someone who can help you understand the legal matters makes the situation less confusing. The SVC also gave myself someone else to talk to about the situation who understood.”

“The legal side for someone not familiar with the all the military laws and processes that one goes through is a lengthy, confusing and scary rollercoaster, a SVC is there to enforce you rights, guide you through the scary stuff and fight for what you actually want.”

Interest items:

- SVC-represented Clients who Converted from Restricted to Unrestricted – 59 of 129 (46%)
- FY 14 SVC –represented Clients who Converted from Restricted to Unrestricted - 28 of 76 (37%)
- FY 13 SVC –represented Clients who Converted from Restricted to Unrestricted - 31 of 53 (58%)
- Compare: In FY12, 15% of restricted reports converted to unrestricted
- Compare: In FY11, 13% of restricted reports converted to unrestricted


Other Items:

U.S. AIR FORCE






